Abandoned Well Sealing Application Form

ELIGIBILITY

The Northeast Red Watershed District (NRWD) delivers programming with the partnership from multiple organizations. To be eligible for programming, you must **own or rent** land within the NRWD boundaries in the following Rural Municipalities: *Brokenhead, Lac du Bonnet, Reynolds, Springfield, St. Clements, Ste. Anne, or Taché.*

Sealing abandoned wells is important in preventing contamination of groundwater and can eliminate safety concerns associated with open wells to humans and livestock.

Applicants must:

1. Pay **\$100** per application. Cheque payable to Northeast Red Watershed District.
2. Arrange a licensed well sealer to complete the well sealing work as per **The Groundwater and Water Well Act**.
3. Provide the Northeast Red Watershed District with a detailed quote from a licensed well sealer.
4. Proceed with well sealing work after approval by the Northeast Red Watershed District.
5. Provide the Northeast Red Watershed District with:
 - a) Copy of the Well Report submitted to the Province of Manitoba, and
 - b) Before and after pictures of the well.

The NRWD will reimburse the landowner the invoiced amount from work completed up to a **maximum of \$3000** to seal an abandoned well. There is no limit to the number of applications a landowner can submit however, one application must be submitted per well.

3. CONDITIONS

The Landowner shall:

1. Pay **\$100. Make cheque payable to Northeast Red Watershed District.**
2. Arrange a licensed well sealer to complete the well sealing work as per **The Groundwater and Water Well Act.**
3. Provide the Northeast Red Watershed District with a detailed quote from a licensed well sealer.
4. Proceed with well sealing work after approval by the Northeast Red Watershed District.
5. Not alter, remove, or modify the project without written consent of the District.
6. Indemnify and save harmless the Northeast Red Watershed District, their agents, engineers, servants, and/or employees from any liability which may result from this project.
7. Provide access for inspection or evaluation by the Northeast Red Watershed District representative at any reasonable time.
8. To receive reimbursement, must provide the Northeast Red Watershed District with:
 - c) Detailed invoice and proof of payment from work completed,
 - d) Copy of the Well Report submitted to the Province of Manitoba, and
 - e) Before and after pictures of the well.

The Northeast Red Watershed District shall:

1. Notify the landowner regarding the status of their application(s).
2. Reimburse the landowner the total invoiced amount from work completed up to a **maximum of \$3000**, provided that the Northeast Red Watershed District receives from the landowner; a copy of a detailed invoice and proof of payment from work completed, a copy of the well sealing report submitted to the Province of Manitoba, and before and after pictures of the well.
