Rain Garden Application Form

Objective: To establish water-capturing gardens to reduce pollutants from stormwater and restore natural infiltration.

Activities: Constructing gardens meant to capture water run-off from rooftops, lawns, driveways, etc.

1. ELIGIBILITY & FUNDING

The Northeast Red Watershed District (NRWD) delivers programming with the partnership from multiple organizations. To be eligible for programming, you must **own or rent** land within the NRWD boundaries in the following Rural Municipalities: *Brokenhead, Lac du Bonnet, Reynolds, Springfield, St. Clements, Ste. Anne, or Taché.*

Cost-Share: 75% NRWD and 25% landowner up to a maximum of \$750 from NRWD.

3. CONDITIONS

The Landowner shall:

1. Submit a detailed rain garden worksheet (separate document).
2. Understand that all projects are subject to available funds and projects **must be approved** by the Northeast Red Watershed District Board and staff **prior** to construction or installation of projects.
3. Maintain the rain garden for a minimum of 5 years after construction.
4. Not alter, remove, or modify the project without written consent of the district.
5. Indemnify and save harmless the Northeast Red Watershed District, their agents, engineers, servants, and/or employees from any liability which may result from this project.
6. Provide access for inspection or evaluation by the Northeast Red Watershed District representative at any reasonable time.
7. To receive reimbursement, must provide the Northeast Red Watershed District with:
 - a) Detailed invoice and proof of payment from work completed;

- b) A signed project agreement; and
- c) Before and after pictures of the project.

The Northeast Red Watershed District shall:

1. Notify the landowner regarding the status of their application(s).
2. Reimburse the landowner the specific shared cost of **75% NRWD and 25% landowner** up to a **maximum of \$750**, provided that the Northeast Red Watershed District receives from the landowner; a copy of a detailed invoice and proof of payment from work completed, a signed project agreement and before and after pictures of the project.
3. Retain the right and privilege for preserving and publicizing the project (i.e., posting signage and referencing the site/project in media releases).

4. DECLARATION AND SIGNATURE

I hereby declare that I have read the conditions, and I agree to abide by the conditions. I further agree to cooperate with the Northeast Red Watershed District in this regard.
